

This program is open to:

- Candidates who hold membership of a recognized professional accounting body, a finance related degree or an MBA/Masters in Accounting.
- Professionals with at least 10 years of management in finance or senior business functions.

Conditions for acceptance onto the program

Applicants must submit a detailed CV which includes:

- personal details;
- academic qualifications;
- detailed work experience.



CIMA will review the CV and assess for both eligibility into the program and confirmation of practical experience.

The CIMA exam should be attempted within 12 months upon registration with CIMA.
